Installation Instructions

1. INTRODUCTION

The RDR-3 and RDM-3 (Mullion type) are external proximity readers, compatible with the AXS-10/AXS-10 PRO access control system.

The system is designed to limit access to restricted areas, while permitting authorized people to enter.

It is recommended to install the reader on a wall outside the protected area, and the AXS-10/ AXS-10 PRO control unit inside the protected area.

Proximity access cards or tags are used as keys to open doors. When presented to an RDR-3/RDM-3, the access card emits a coded RF signal that is read by the proximity reader.

The reader then forwards this signal to the AXS-10/ AXS-10 PRO control unit

The control unit verifies that the card is valid and decides whether it should energize an output relay that releases the lock.

For information about the AXS-10 system, refer to the AXS-10 user's guide and installation instructions.




Figure 1 - External View

3. MOUNTING

Mount the proximity reader outside the door on the wall or door frame. The RDR-3 is supplied with a 1m (3 ft) cable.

Note: Do not install the RDR-3/RDM-3 on a metal surface or a metal door frame, since this decreases the read range significantly. If you have to install the reader on a metal surface, use a non-metallic spacer so that the reader will be at least 1 cm (3/8 in.) away from the metal. You may use RDR-BACK (for RDR-3) or RDM-BACK (for RDM-3) that is a spacer made specifically for this purpose.

Close cover. Verify that the lens is aligned with the LED.

Mark and drill 2 holes in mounting surface. Fasten the unit to mounting surface use the spacer RDR-BACK.

Note: When installing more than one RDR-3/RDM-3, the distance between the readers should be at least 60 cm (2 ft.), to ensure proper operation




Figure 3 - RDM-3 Mounting

4. WIRING

The standard cable is color-coded. Use a cable with the same colors to avoid mistakes in connection.



Connecting One RDR-3/RDM-3 Reader to AXS-10 System



This warranty shall apply to the Product only. All products, accessories or attachments of others used in conjunction with the Product, including batteries, shall be covered solely by their own warranty, if any. The Manufacturer shall not be liable for any damage or loss whatsoever, whether directly, indirectly, incidentally, consequentially or otherwise, caused by the malfunction of the Product due to products, accessories, or attachments of others, including batteries, used in conjunction with the Products.
